After having a chance to review these suggested changes, I would like to request that there be some consideration for the sheer quantity of assessments we are administering to students. For example, if Kindergarten needs to give KRA, couldn't that serve as one of the data points for this reporting? Additionally, the number of choices in the alpha ranking is overwhelming. Furthermore, we always use more than one data point to make determinations about students' ranking as either not on track or on track. This limits our ability to use multicriteria to do so. I think the on track/not on track reporting for all reporting purposes is much more clear and will serve to likely be more consistent overall.
